

OPERATING RULES

Regulating Vehicle Entry and Stay on the Owner's Property

These operating rules (hereinafter referred to as the "OR") regulate the conditions for entering and staying with a vehicle on the owner's property, which has been designated and marked for this purpose by the owner's decision (hereinafter referred to as the "property"). The exact specification of the property is included in Appendix No. 1 of the OR – the price list.

Owner's Consent for Entry and Stay on the Property

A vehicle driver is allowed to enter and remain on the property for more than 10 minutes (the necessary time for passengers to board or exit the vehicle) only if they accept these OR and pay the fee for obtaining the owner's consent for vehicle entry and stay on the property (hereinafter referred to as the "fee").

The property owner grants consent for vehicle entry and stay only to the driver of a specific vehicle who accepts these OR and simultaneously pays the fee for a time-limited consent (hereinafter referred to as the "consent"). The driver's authorization to remain on the property is subject to obtaining the owner's consent, which is always valid until 24:00 on the day the vehicle enters the property, provided the OR is accepted and the fee is paid.

Only personal vehicles are allowed to enter the property. Trucks, vans, motorhomes, and other vehicles exceeding a length of 5.5 meters are prohibited from entering unless the property owner decides otherwise.

By entering the property, the vehicle driver automatically agrees to these operating rules and commits to complying with them unconditionally.

Payment of the Fee

After parking, the vehicle driver is required to pay the fee at the designated automatic payment machine provided by the property owner (hereinafter referred to as the "machine"). The fee amount is determined by the price list set by the property owner, published on the machine, at the VRÁTNA Malá Fatra Resort information center (hereinafter referred to as the "resort"), on the resort's website www.vratna.sk, and attached as an appendix to these rules.

The fee can be paid:

- a.) Cashless – by payment at the machine or using the QR code displayed on or near the machine.
- b.) In cash – at the Panoráma buffet, located at the entrance to the lower station of the Chleb cable car.

The fee is a fixed amount for the entire day in which the vehicle enters the property and is parked there, starting at 00:00:01 and ending at 23:59:59. The duration of the vehicle's stay on that day does not affect the fee amount. If the vehicle remains parked beyond 24:00, the owner's consent becomes invalid, and a new fee must be paid for the next day.

Fee Exemptions

Holders of a disabled parking permit (ZŤP) who are immobile are exempt from paying the fee. To receive consent, they must accept these OR and visibly place their disabled permit behind the windshield for the entire parking duration.

Additional Property Use Conditions

- The maximum vehicle speed on the property is limited to 10 km/h.
- The consent system includes license plate recognition.
- Vehicles obstructing normal property operations or parked in violation of these OR will be removed at the owner's expense.
- The property is not guarded, and the owner is not responsible for belongings left inside vehicles.

Prohibited Activities on the Property

- a.) Smoking, open flames, or handling hazardous substances.
- b.) Presence of persons under the influence of alcohol or drugs.
- c.) Parking outside designated areas.
- d.) Damaging the property or owner's equipment.
- e.) Performing vehicle repairs or maintenance, including refueling.
- f.) Littering (e.g., cigarette butts, food waste, vehicle fluids, or human waste).
- g.) Begging, performing street entertainment, gambling, or any unauthorized commercial activities.
- h.) Selling goods or distributing promotional materials without written approval from the owner.
- i.) Photographing or filming for commercial purposes without prior written consent.
- j.) Driving lessons on the property.
- k.) Remaining in a parked vehicle longer than necessary.
- l.) Using bicycles, scooters, rollerblades, skateboards, or similar means of transport.
- m.) Leaving children unattended or allowing loose pets to roam freely.

Driver and Visitor Responsibilities

Drivers must report any equipment malfunctions (e.g., payment machine issues) or safety concerns to the property owner.

The property is private, and the owner or authorized personnel may ask violators of these OR to leave.

Disclaimer

The property owner reserves the right to modify or supplement these OR. The owner is NOT responsible for vehicle damage, theft, or belongings left in the vehicle. By using the property, the vehicle owner, driver, or any user fully accepts these OR and agrees to comply with them.

If the property is monitored by security cameras, its operation follows GDPR regulations. More information about personal data processing can be found at www.vratna.sk.

Failure to comply with these rules will result in the withdrawal of the owner's consent for vehicle entry and stay, without a refund of any portion of the fee. If consent is withdrawn, the vehicle must leave the property immediately.

Appendix No. 1:

Price List for Vehicle Entry and Stay on the Property

A.) Fee per day (00:00 – 24:00): **10 EUR** (flat rate, regardless of entry time).

B.) Contractual penalty for unpaid fees per day and vehicle: **200 EUR**.

These operating rules regulate the rights and obligations of individuals on the property located in the cadastral area of Terchová, specifically:

- Parcel No. 16154/130 KN C – built-up area and courtyard, 2932 m².
- Parcel No. 16154/131 KN C – built-up area and courtyard, 444 m².
- Additional parcels: 130/2932m, 131/444m, 130/4475m, 132/4169m, 134/844m, 330/1600m, 155/230m.

These properties are registered at the District Office of Žilina, Cadastral Department, on Title Deed No. 2526.
